

# Thomas More College Fee & Levy Schedule 2024

All fees and levies will be invoiced at the commencement of Term 1.

### 1. <u>Tuition Fees (per student)</u>

Tuition Fees are to be paid in line with the 2024 Payment Agreement. We are asking <u>all</u> families to complete a Payment Agreement to inform the College of your commitment to pay the tuition fees and other associated charges (including outstanding fees) during the 2024 school year. If a family wishes to alter arrangements, they must contact the College Finance Office.

All accounts must be settled by 9<sup>th</sup> August 2024, unless subject to an approved payment agreement.

- Term 1 fees due 9<sup>th</sup> February 2024
- Term 2 fees due 10<sup>th</sup> May 2024
- Term 3 fees due 9<sup>th</sup> August 2024

# 2. Curriculum Levy (per student)

The Curriculum levy is used to cover whole school or whole year level activities including the use of IT device.

# 3. Building Fund Donation (per family)

An annual Building Fund Donation of \$270 is requested by each family. This voluntary donation will help support new building projects, hasten the redevelopment of existing buildings, and assist in the maintenance of existing buildings. The donation is fully tax deductible.

It is included in the first account of the year and will not appear on any further statements for that year.

#### Discounts Available on Tuition Fees

- Families with more than one child attending Thomas More College receive discounts on Tuition Fees of 20% for the second child, 35% for the third child and 90% for any additional children.
- On application, families that are eligible for School Card will receive a discount on Tuition Fees in lieu of any other discount. Thomas More College will apply a discount to families eligible for School Card of 50% for incomes up to \$70,994. If you feel you may qualify for such a discount, please contact the College Finance Office. You must apply for School Card discount in 2024 and every subsequent year.
- A 3% Sibling discount will apply on Tuition Fees to all (non-school card) families that have a child attending a Catholic Primary School.
- If additional financial assistance is required, please contact the College Finance Office.

#### Payment Options Available

The College provides families with a variety of methods for ease of payment. These include:

- Direct debit from your bank account or credit card
- Direct Deposit
- Centrepay
- Bpay
- Cash/Cheque/EFTPOS

Parents are asked to complete their 2024 Payment Agreements and return them to the College Finance Office <u>no later than Friday 8<sup>th</sup> December 2023</u>. If you wish to deviate from the approved payment options, you must speak to the College Finance Office.

Parents that are experiencing financial difficulties and/or are unable to pay the fees and levies within the time frames advised, are required to discuss their options with the College Finance Office.
